Dear Chairman Goodlatte:

On behalf of American dairy farmers, we want to thank you for your efforts to address one of the most vexing problems facing our collective memberships: how to create a viable, legal framework to address the year-round labor needs of the dairy industry.

The Agriculture Guestworker Act (AG Act) represents a significant, positive step forward in solving the most acute labor problem our farmers face: access to a reliable and steady labor force. Our organizations look forward to working with you, the other members of the Judiciary Committee, the leadership of the House of Representatives, and other stakeholders, to advance this legislation in 2017. We recognize that your proposal is the best vehicle to arrive at a balanced solution to the immigration conundrum.

America's dairy farmers, and other employers who have perennial and not just seasonal labor needs, desperately require a workable program that allows them to access a consistent, legal, and dependable workforce. The AG Act creates such a program. We are appreciative that the act reflects the input that our organization and its members have offered to your committee as the measure was developed. Specifically, the AG Act recognizes that the status quo is unacceptable, as well as that enforcement-only measures could prove disastrous for the farm sector, and thus cannot be the first or only basis for fixing our broken immigration system.

This legislation is a rare opportunity to resolve several of the most challenging aspects of how to create a legal means of addressing the supply and demand elements affecting agriculture. The AG Act deals both with the challenges facing current workers, while also creating a new visa category to bring in future agriculture workers—workers that our dairy farmers will continue to rely on.

We recognize that this is the first step in what will be a lengthy process, involving input from many groups and other lawmakers as well. We look forward to continued collaboration as this measure moves forward, because we cannot wait any longer for action. The future of the dairy sector, and all of American agriculture, depends on us seizing this opportunity to finally resolve this issue.
